



EASTON FARMERS' MARKET – VENDOR AGREEMENT

This Agreement is between Greater Easton Development Partnership, Easton Farmers' Market (EFM) and ("Vendor").

Whereas, Vendor has been approved as a vendor for the EFM for 2021, subject to the terms and conditions of this Agreement.

Now Therefore, Vendor agrees as follows:

- 1. Vendor Representations.** Vendor affirms that all of the information and representations in the Vendor's application for admission to the market are true and correct, including without limitation that Vendor grows or produces its items for sale at EFM.
- 2. By-Laws.** Vendor shall abide by all By-Laws of the EFM, attached hereto and incorporated herein, as such may be modified from time to time. Vendor confirms that Vendor has read the By-Laws.
- 3. Rules and Regulations.** In addition to the By-Laws, EFM retains the right to establish and modify Rules and Regulations from time to time related to the operation of the Market and for the safety of EFM staff, vendors, and customers and the general public, as it deems necessary in its sole discretion. Vendor shall abide by all EFM Rules and Regulations.
- 4. Termination.** EFM may terminate this Agreement and the Vendor's right to operate at the EFM in the event of Vendor's breach of this Agreement or any rule or regulation established by EFM, or in the event the EFM closes the market due to natural disaster, government or Court order, weather, pandemic, or other cause beyond the control of EFM. In the event of termination of this Agreement, Vendor shall not be entitled to refund of fees or other amounts paid to EFM or any other entity or in connection with any expense of operating at the EFM.
- 5. Special Operations – Covid-19 Pandemic.** In addition to all other Rules and Regulations, Vendors shall assure compliance with the following special operations until further written notice:

Vendor Safety Regulations

- a. If a vendor or member of their staff is sick, they cannot be onsite at the market and the vendor must immediately notify Easton Farmers' Market management. See Covid-19 Symptoms*
- b. If a vendor or member of their staff tests positive for Covid-19, the vendor must immediately notify EFM Management and the vendor or staff member will not be

permitted to return to the market for 14 days from onset of symptoms. See: CDC isolation procedures <https://www.cdc.gov/coronavirus/2019-ncov/if-you-are-sick/isolation.html>

- c. If a vendor or member of their staff has been in close contact with someone who has tested positive for COVID-19, has a presumed case of COVID-19, or is sick with COVID-19-like symptoms, the vendor must immediately notify EFM Management and the vendor or staff member will not be permitted to return to the market for 14 days. - d. All vendors and their staff must wear protective masks or face shields unless fully vaccinated.
- e. Vendors must have hand sanitizer at their stand for their use and customer use.

***Symptoms of COVID-19, according to the PA Dept. of Health, can include:**

- Fever. If you have a temperature above 100 degrees Fahrenheit, stay home.
- Chills. Including repeated shaking with chills.
- Muscle pain or body aches.
- Headache or confusion.
- Difficulty staying awake or waking up.
- Cough.
- Shortness of breath or difficulty breathing. May have bluish lips or face.
- Congestion or runny nose.
- Sore throat.
- New loss of taste or smell.
- Nausea or vomiting.
- Diarrhea.
